# ARTICLE 2: Chapter E Zoning Bylaws Floodplain District – 4.4(b) District Delineation & Article 4.4(c) Use Regulations

To amend the Zoning Bylaw, Chapter E, Article 4.4(b) District Delineation and Article 4.4(c) Use Regulations, as follows:

"Article 4.4(b) District Delineation – The Floodplain District is herein established as an overlay district. The District includes all special flood hazard areas within the Town of Rehoboth designated as Zone A and AE on the Bristol County Flood Insurance Rate Map (FIRM) issued by the Federal Emergency Management Agency (FEMA) for the administration of the National Flood Insurance Program. The map panels of the Bristol County FIRM that are wholly or partially within the Town of Rehoboth are panel numbers 25005C0117F, 25005C0118F, 25005C0119F, 25005C0136F, 25005C0137F, 25005C0138F, 25005C0139F, 25005C0143F, 25005C0206F, 25005C0207F, 25005C0208F, 25005C0209F, 25005C0217F, 25005C0226F, 25005C0227F, 25005C0229F, 25005C0236F and 25005C0237F dated July 7, 2009; and panel numbers 25005C0216G, 25005C0218G, 25005C0219G, 25005C0238G and 25005C0239G dated July 16, 2014. The exact boundaries of the District may be defined by the 100-year base flood elevations shown on the FIRM and further defined by the Bristol County Flood Insurance Study (FIS) report dated July 16, 2014. The FIRM and FIS report are incorporated herein by reference and are on file with the Town Clerk, Planning Board, Building Inspector and Conservation Commission.

Article 4.4(c) Use Regulations – The Floodplain District is established as an overlay district to all other districts. All development in the district, including structural and non-structural activities, whether permitted by right or by special permit must be in compliance with Chapter 131, Section 40 of the Massachusetts General Laws and with the requirements of the Massachusetts State Building Code which addresses floodplain and coastal high hazard areas (currently 780 CMR); as well as the Wetlands Protection Regulations, Department of Environmental Protection (DEP) (currently 310 CMR 10.00); the Inland Wetlands Restriction, DEP (currently

310 CMR 13.00) and the Minimum Requirements for the Subsurface Disposal of Sanitary Sewage, DEP (currently 310 CMR 15, Title 5)." or take any other action relative hereto.

### Residents of Rehoboth

Like many communities throughout the Commonwealth of Massachusetts, Rehoboth faces a challenge to achieve a balanced budget. The Town's staff and volunteer officials work extremely hard to develop a prudent spending plan that includes the educational needs of our children as well as all other health, human services and public safety needs of our community and all our citizens.

Annual Town Meeting approved the Fiscal Year 2015 Town operating budget contingent on an Override of Proposition 2 ½ (the Dighton Rehoboth Regional School budget assessment is exempted from this override vote as a result of a prior vote at Town Meeting).

An increase to the School's assessment, over what had been recommended by the Finance Committee, was voted after multiple nights of Town Meeting discussion. The only way to fund this operating increase and to sustain the same level of non-educational government services now and in the future is through a Proposition 2 ½ Override.

Because of Massachusetts General Law timing requirements, the Board of Selectmen could not schedule an Override vote prior to Tuesday, July 15, 2014; and therefore, because of the contingent nature of the budget, the Town effectively has no budget as of July 1<sup>st</sup>. In other words, as of July 1<sup>st</sup> the Town cannot fund any non-educational government services – including its police department, fire department, library and senior center. When advised of these circumstances by Town Counsel, the Selectmen voted to seek approval of a temporary spending plan rather than simply shutting down all municipal operations on July 1<sup>st</sup>.

The temporary budget will be presented at a <u>June 30<sup>th</sup> Special Town Meeting</u> to approve a 90-day operational budget for the Town. This will prevent the shut-down of Town services on July 1<sup>st</sup>.

We also remind you of the upcoming Override vote at the <u>Tuesday</u>, July 15<sup>th</sup> Special Election which will be held from 7:00 a.m. until 8:00 p.m.

- If the Override question is approved, then operations of the Town government will continue at the level of services you have come to rely on.
- If the Override question were to be defeated, or not approved, then the Selectmen will need to call for another Special Town Meeting during the month of August (most likely Monday, August 11<sup>th</sup> or 18<sup>th</sup>) and Town Meeting will have to cut programs and services which will need to equal approximately 22% of the proposed FY15 budget or \$1,658,740 (the amount of the proposed override).

Please attend the **Special Town Meeting on Monday**, **June 30**, **2014 at 7:00p.m**. at the Dighton Rehoboth Regional High School to approve a temporary 90-day budget; and please vote at the **Special Election on Tuesday**, **July 15**, **2014**.

We need your help and support to keep our Town a wonderful place to live.
