Town Administrator's Report:

Reminder, tomorrow November 3rd is Election Day. All Precincts will vote at the Palmer River Elementary School-Gymnasium. Polls open at 7AM – 8PM. The Town Clerk's office is asking all attendees to please wear face coverings. Thank you to all residents that have already voted during the Early In-Person voting Session. As of Friday, October 30th, approximately 2000 residents attended early voting. Town Clerk's office also received approximately 4000 mail in ballots as well.

- Town Counsel has reviewed and made all proper changes to the Highway Superintendent's Contract. Copies will be provided in the Selectmen's packets for next week for your review and vote.
- Our Veteran's Officer Jake Kramer has asked me to announce that there will be a small social-distanced Veteran's Day Ceremony on November 11th at 11:00 AM at Redway Plain. The Minutemen will be present to fire a volley to honor all veterans, and the Boy Scouts will present their Eagle Scout project of granite benches.
- COVID-19 updates, Town Nurse, Rehoboth in the red, as is surrounding towns. Starting Friday Gov Baker issues curfew, for restaurants, gyms from 10:00PM till 5:00AM.

NEW BUSINESS:

Action Item #1: Discussion re: Letter to Petitioners from the Board

Michael McBride and James (Jay) Crandall were present to represent the group of petitioners wanting to place an Article on the Town Meeting Warrant to withdraw grades K-8 from the Regional School District in accordance with Section 9 of the Regional Agreement.

The Board of Selectmen have set the date for the Annual Town meeting for December 1st. Chairman Vadnais explained why we need to have Town Meeting, in order to set the tax rate, but are faced with several obstacles of holding a large gathering as such, due to the COVID-19 restrictions. Therefore, the plan is to keep the Warrant as non-contentious as possible so as to keep the number of attendees low. Postponing this Article by petition will help keep the numbers down.

Each member of the Board present, Jim Muri, Skip Vadnais, and Dave Perry, personally pledged that they would make sure it was on the next Warrant after the state of emergency is lifted.

J. Muri motion to accept the Petitioners' letter to postpone the Article on K-8 de-regionalization and to add it to the next Town Meeting Warrant after the State of Emergency is lifted, with placement as the first order of business. Second by D. Perry. Vote 3-0.

Discussion:

Financial Summit that will cover what is on the Warrant will be held before Town Meeting, with Finance Committee member Michael Deignan. Town Moderator Bill Cute will also hold a mock Town Meeting to go through how the meeting will play out. Call-ins will be allowed for residents to have their questions answered regarding the budget numbers, so everyone can have a complete understanding of what will be voted on at Town meeting.

Action Item #2: Vote to Approve Superior Officers MASSCOP #208 MOA
