Town Administrator's Report:

The Green Energy Committee chairperson Carolyn Panofsky would like to speak to the liaisons to the Police department regarding a possible grant for turning the police cars into hybrids. She can come into speak to the BOS or do it via telephone.

-S. Vadnais spoke with her and she will be putting together a packet for the BOS/Police Chief for further discussion.

We had a call from the insurance company regarding the COA. We will be receiving 2 checks; one for the building loss for just over \$2M, one for contents for \$168,000 plus. Once we start bid project, these amounts may be adjusted upwards. RFP for OPM and architect is with Ben, (Town Counsel). OPM is first priority, as they will help with creating RFP for contractor, etc., then the architect.

The Board of Health may be looking for 2 floaters to replace current employees' vacancies at Transfer Station. One out due to injury, one resigning due to health issues.

NEW BUSINESS:

Action Item #1: Discussion RE: CARES Funding for DRRSD & Possible Approval

Selectman Schwall discussed the request the BOS received from Paul Kitchen to fund computers and other equipment using our CARES funds, for a total of \$112,613.47.

- G. Schwall motion to approve a disbursement of \$52,152.70 from the CARES funds to Palmer River Elementary School for the purchase of sanitizing wipes, automatic flushing system and staff laptops (ACER Travelmate), contingent upon receipt of a signed agreement from school Committee to agree to reimburse if needed because of charge backs. Second by J. Muri. Vote 4-0.
- G. Schwall motion to approve a disbursement of \$60,460.77 from the CARES fund to Beckwith Middle School for the purchase of sanitizing wipes, automatic flushing system, water fountain installation and staff laptops (Lenovo Thinkpads), contingent upon receipt of a signed agreement from School Committee to agree to reimburse if needed because of charge backs. Second by J. Muri. Vote 4-0.

Discussion:

G. Schwall gave an update on the CARES Act and what the Federal Government are going to do. At this point, no extension given to municipalities. He went into further discussion on the DRRSD request. In earlier discussion it was voted to pay for student Chromebooks for school. They received funding from the State for them, so we do not need to fund. The benefit to the Town is that we will not see the laptop cost on an assessment in the future.

If one of these items were not eligible per the State, or if school "double-dipped" and audit discovered it, we would not be at fault. G. Schwall asked in writing for an acknowledgement from the school committee, still waiting for reply. Motion to address that Board was agreed.

Action Item #2: Discussion RE: Electric Aggregation Residential Program

This past April the ITA signed a contract with the approval of the Board with Constellation to provide our residents with continued electric savings. This is a 3-year program beginning January 2021. The price per kWh for our residents will be \$.10470. Information will be sent to all residents within the coming weeks. This is an automatic program. For residents that would like to OPT out of the program, they would have to contact Constellation. The information that is being sent to the residents will explain the OPT out procedure. If you would like to stay in it, you do not need to do anything. The pricing for Constellation will be added to everyone's National Grid monthly billing, starting with the January 2021 billing. If anyone has any questions, they can call the BOS office and we will help them.

Action Item #3: Vote to Approve 2021 Common Vic Licenses Renewals
