# Action Item #1: Vote to Approve Warrant for 2020 Presidential Primary

The Town Clerk has prepared the Warrant for the Presidential Primary for the Selectmen's signature so they may be posted. The primary will be held on Tuesday, March 3, 2020 and all three precincts will be open from 7:00 AM - 8:00 PM.

# Action Item #2: Vote to Approve CCC Information Technology Grant and Authorize Chairman to Execute Required Grant Documents on Behalf of the Town

IT and Media Director, Derek Rousseau, applied for a Community Compact Cabinet Information Technology Grant on behalf of the Town. The grant was approved and the Town was awarded \$134,707.50. The funding will be used to expand the Town's fiber network to benefit municipal and public safety agencies.

M. Costello motion to approve CCC Information Technology Grant and authorize the Chairman to execute grant documents on behalf of the Town. Second by S. Vadnais. Vote 4-0.

#### Discussion:

- D. Rousseau expanded upon this information, saying that the grant money will be used to extend the fiber network to the North Fire Station, South Fire Station and the Public Safety towers.
- J. Muri added that this is going to make our communication faster, more reliable and less expensive, and that Rehoboth was one of the top grant recipients in the State.
