Action Item #2: Vote to Approve Location for the Town Election - April 6, 2021

The Town Clerk Laura Schwall was present to request the vote of the Board on the new location for the Town Election on April 6th – D.L. Beckwith Middle School.

G. Schwall motion to approve the D.L. Beckwith Middle School as the location site for the Rehoboth Town Elections being held on April 6, 2021. Second by J. Muri. Vote 4-0.

Action Item #1: Vote to Accept and Sign Conservation Committee Restriction-28 Smith Street-Blue Heron Estates

<u>Action Item #2: Vote to Accept and Sign Planning Board Retreat Lot Restriction – 155 Perryville Road-Rehoboth Country Club</u>

The Planning Board is asking the Boards approval and signature on the Declaration of Covenants, Conditions, Restrictions, Charges, and Liens document. This is also defined in MGL Chapter 184 and also Chapter 41, Section 81-L (Subdivision Control Law), and 81P and X (Registration of Plans). The purpose of this restriction is to prevent from any further subdivision or division of said real estate – 155 Perryville Road, retreat Lot 2 – Rehoboth Country Club. Per our Town Counsel this procedure needs to take place and in past years has not.

M. Costello motion to approve and sign Retreat Lot Restriction for 155 Perryville Road- Lot 2. Second by G. Schwall. Vote 4-0.
