Action Item (1): Review May 14, 2022 Annual Town Meeting Warrant with Town Moderator & Town Clerk

Review of the Warrant with Mr. Bill Cute and Laura Schwall. Mr. Cute would like to get the Town Meeting done in one day. (Timestamp 9:15)

- 1. The votes will be cast by using electronic clickers for the first time. Everyone will be able to test their clickers and practice them at the beginning of the meeting.
- 2. Article 9 will be pulled from the consent agenda and will be treated as an article that will be amended to add the report of the water and housing commission to the BOH report.
- 3. Advised the public to read the comments and educate themselves on the Articles.

- 4. If there isn't a unanimous vote on the consent agenda, Article 2 will need to be pulled from the consent agenda.
- 5. Article 36 might need to be tabled due to public hearing dates. Skip addressed this issue clarifying it has technical problems because the hearing was not advertised or posted on time. The warrant was already printed, so the public hearing that was held had no meaning behind it.

Action Item (2): Discussion with AgCom Representative Re: COA Kitchen Garden, with possible action

Per the request of Tish Vadnais, she would like to discuss the COA Kitchen Garden with the BOS. Tish Vadnais stated Ag-Com would like to sponsor a COA Kitchen Garden. Tish spoke to the Garden Club and Recreation Committee. Blueprints were included in the proposal, and an Eagle scout could possibly take on the project when the time comes.

- M. Deignan asked Rachel about the Conservation Restrictions. Rachel stated anything can go in the injunrestricted areas, but irrigation and water filtration systems should be considered in this proposal. Tish mentioned using Buffalos with rainwater.
- M. Deignan motion to authorize Ag-Com to proceed with drafting a plan for placement and installation of the COA Kitchen Garden at Francis Farm, and return back with a finalized plan. Second by G. Solas. Vote 3-0.

To finish off the year we estimate an additional \$9890 will be needed. Some vendors have not returned our calls, so Carol used past information to accommodate our needs.

- M. Deignan motion to accept the plan as submitted and further to ask the CPC to engage Wildlands Trust to present us with a proposal. Second by G. Solas. Vote 3-0.
- M. Deignan motion to accept the invoice in the amount of \$3,950 for the surveying services at 27 Francis Farm Road and to authorize the Town Accountant to pay forth with. Second by G. Solas. Vote 3-0.

The Town could either take two personnel and two trucks to load the scrap and transport it, or a bin could be dropped off and loaded by one personnel. G. Solas suggests taking one personnel to load the scrap. M. Deignan doesn't think any Highway Department employee should be used due to street repairs that need to be done. M. Deignan suggested soliciting bids to remove the scrap to get the most for the money. S. Vadnais gave an overview of the estimated costs.

- S. Vadnais said the Fire Chief proposed finishing a room off and using it for training and truck storage. Funding could come from Federal money. Skip had a discussion with Gerry and is now asking Mike to look into that possibility. Some outdated fire department items will be donated to 3rd world countries. A proposal will be coming regarding some underground space at the castle.
- M. Deignan stated he has never been in the Castle Building, and the intent was not for public use. M. Deignan has no issue with the fire or police chief utilizing the garage and room above for training. The only concern is about the well since the building will be used by town employees since there should be bathrooms.
- S. Vadnais is looking for permission to allow the Fire Department to develop the training facility and come up with costs.
- M. Deignan motion to allow the Rehoboth Fire and Police Department to co-share the garage area at 2 South Old Anawan St. for vehicles and associated equipment. Second by G. Solas. Vote 3-0.
