- -S. Vadnais- Regional agreement outdated and unfair to Rehoboth. Needs to change. Hoping for the best.
- -Jay Crandall, Danforth Street, asked if the representatives from the state would be at the meeting with the school committee. Senator Finney and Representative Howitt will both be there at the state house.

 - -Dr. Azar to bring updates to BOS meeting monthly.
 - -New Regional agreement can be decided and voted on by 1/2020.
 - -Regional agreement need to be fair and equitable to both towns.
 - -The goal is more transparency on this issue.
