although it comes from tax dollars in the Commonwealth, it does not come from direct tax dollars from Rehoboth.

<u>Johnson:</u> This Saturday, August 12<sup>th</sup> at 10:30 AM, there will be a grand opening of the Rehoboth Pet Pantry, which is located in front of the animal shelter and, it's a project by a local Girl Scout. At 10:30. Donations will be accepted at this time.

<u>Mills</u>: Highway department- continues working on drainage issues throughout the Town; working on intersections that are hard to see and other issues that are challenges in the Town, i.e. Tremont Street paving project which is an expensive and lengthy project that the Highway Superintendent Kevin Chace has obtained Chapter 90 funding for.

Building Department- continues to work on parking, painting and Town buildings (alongside Maintenance Department), going around and removing & replacing rotten wood. Looking to the future with these types of remedies being done. We are working in the Police Station, replacing floors, which is needing to be done and the job should be done within 2-3 days

Speaking regarding the Building Department- the difference between a Building Inspector and a Building Commissioner- Comm. approves plans, does inspections and has vested authority, by not only the Town but by the Commonwealth, to issue Cease & Desist, declare buildings unsafe (if they are unsafe), etc. Mark Arruda, who was Assistant Building Inspector, is qualified to be a building commissioner after taking classes and passing, and that's why tonight we rescinded the appointment as the Building Inspector and reinstate him under a different title as Deputy (under our Building Commissioner)- Deputy Commissioner. He now has authority to take care of issues in the absence of the Building Commissioner.
