#### 1.) Call to Order: 6:00 PM

Chairman Vadnais called the regular meeting of the Board of Selectmen to order at 6:00 p.m.

#### **Business for Discussion:**

<u>Announcements:</u> Next Selectmen's meeting will be on Monday, October 24, 2016 at the Senior Center starting at 6:30 PM in Executive Session [continuation of discussion with Mr. Fournier] and 7:00 PM with Superintendent of Streets interviews, continued public hearing with Mr. Fournier, etc.

#### **Action Item (1): REMA Grants**

Bill Maiorano has asked that Chairman Vadnais sign signatory authority forms for the Town when he applies for grants and to sign MEMA Sub-recipient Response Form. It was noted that these documents must now be submitted prior to signing the contract for the grant.

On a motion made by Selectman Pimental, seconded by Selectman Schwall it was voted to approve and authorize Chairman Vadnais to sign forms as requested. Vote 4-0

#### **Action Item (2): Senior Center Heating Renovations Bid**

Selectman Perry noted that all bids received were over budget and that the seniors group had voted to provide \$5,000 in funds to supplement available Town funds. Selectman Pimental stated she did not think we should use their funds. Selectman Schwall indicated that the \$50,000 from the State is still in the State budget and it is just a matter of getting the money. The Board felt the additional needed funds should come from a reserve fund transfer and not the seniors' account. Fincom Chair, Mike Deignan, stated that more than likely the Finance Committee will be able to approve a Reserve Fund Transfer for the \$4,730.00.

On a motion made by Selectman Perry, seconded by Selectman Pimental it was voted to award Senior Center boiler bid to Performance Heating & Plumbing, Medway, MA, for their bid of \$46,300.00. Vote 4-0

On a motion made by Selectman Pimental, seconded by Selectman Perry, it was voted to approve a request for a Reserve Fund Transfer for \$4,730.00 to provide the additional funds needed for the bid accepted for replacement of the boiler at the Senior Center; account into which funds will be placed to be determined.

Selectman Pimental noted that the senior funds offered could be used for any additional inspections by Tom Bryant as needed. Vote 4-0

#### **Action Item (3): Senior Center Electrical Renovations Bid**

Board discussed bid of \$53,698.98 from Power Equipment Co. as being \$4,358.98 over funds available to do project. Selectman Perry indicated that they would hold the bid open until we have received additional funds at the January Special Town Meeting. Board suggested asking the seniors if they would like to switch and use the \$5,000 offered for the boiler for the generator instead. Award of bid will be on hold waiting funding on matter.

#### **Action Item (4): Highway Superintendent Interviews**

Board discussed procedure for conducting interviews for Superintendent of Streets position. Selectman Schwall suggested the three candidates be interviewed individually; one will be interviewed while the other two remain outside the meeting room in the foyer area. Chairman Vadnais stated we can start with the three candidates at the table to greet and introductions, then ask two to leave and interview each candidate individually. Selectman Perry asked about questions to be asked and questioned if the Board members may have all the same questions. Selectman Schwall stated Selectman Perry should take the lead on questioning each candidate and other Board members will follow up. Chairman Vadnais suggested having each candidate, after being interviewed, go back to the foyer area so the Board may reserve the right to bring any one of them back to interview table to address any follow up questions. Mike Deignan will assist with controlling candidates. The Board discussed not making a decision the evening of the 24<sup>th</sup> but taking the decision under consideration and to vote to appoint at a later date.
