Schwall, pursuant to Massachusetts General Law, Chapter 30A, and Section 21; (1) To discuss the reputation, character, physical condition or mental health, rather than professional competence, of an individual, or to discuss the discipline or dismissal of, or complaints or charges brought against, a public officer, employee, staff member or individual. The individual to be discussed in such executive session shall be notified in writing by the public body at least 48 hours prior to the proposed executive session; provided, however, that notification may be waived upon written agreement of the parties. A public body shall hold an open session if the individual involved requests that the session be open. If an executive session is held, such individual shall have the following rights:
- i. to be present at such executive session during deliberations which involve that individual;
 - ii. to have counsel or a representative of his/her own choosing present and attending for the purpose of advising the individual and not for the purpose of active participation in the executive session;
 - iii. to speak on his/her own behalf; and to cause an independent record to be created of said executive session by audio-recording or transcription, at the individual's expense;
- (3) To discuss strategy with respect to collective bargaining or litigation if an open meeting may have a detrimental effect on the bargaining or litigating position of the public body and the chair so declares *

- Chris Gauthier announces he will be the contact between CARCS and the Board of Selectmen. Chris gave an update on meeting with Congressman Kennedy and several other upcoming meetings scheduled. He asked the Board if there has been any mention of a tax break offered to the Town. SV. There has not been. Chris Gauthier mentioned construction being done in the area. D.P.: The Board was informed that there was an anomaly in one of the pipes, so they dug the area up and replaced the pipe. Bob Ashton has been informed about the comprehensive health review and will be doing research with his colleagues and getting back to the Board of Selectmen.

Town Administrator's Report:

- Mayor Dumas called regarding the compressor station. I will be sending him the list of questions from citizens of Rehoboth and he will pass his on to me. Helen will be passing new information on to Mayor Dumas when it is received.
- I am working on the Kennel Permit and revising the renewal form. I have contacted other towns and also Richard Panofsky for input.
- Performance Plumbing & Heating has ordered equipment and he is waiting for it. He will schedule as soon as he knows when it is coming in.
- Power Equipment will be starting the generator this coming Monday.
- I attended a workshop put on by the Attorney General's Office regarding Zoning Bylaw amendments.
- I spoke to Stefano Loretto from Good Energy/ConEd. He wants to come before the Board to give an update. ConEd was also bought out by Constellation.

4.0) NEW BUSINESS: Action Item #1: National Grid Grant

Chief Barresi: I have verbally accepted another Energy Saving Grant for Station 3 to replace fixtures, but unlike the North Station I no longer have a fire fighter that is a journeyman electrician. We would need to hire a licensed electrician to do the work.

On a motion made by S. Pimental it was voted to accept Fire Chief Barresi to obtain quotes to have Station 3 electrical work done Second by G. Schwall. All Vote 4-0

- The fire department has been doing sight work on the property across from the fire station. I acquired a modular building and got rid of the 3 containers that were on the site.

Action Item #2: Well Mapping Project

Ted Ballard & Bill Costa present.

We are working with Roger Williams to set up a data base to make research easier, using well data from the DEP. This will make planning down the road much easier. This will tell us; where the wells are, how deep the water is, where it comes from, how it varies from different areas of Town and we will have data from the 1200 out of the 1900 wells we have in Town. To have access to this data base we need to buy a license and the cost is approximately \$1,000.00 and \$2,000.00 every year after for maintenance fees. I have reached out to Planning Board and Board of Health to help with the funding and no one has money in their accounts. I will have a better understanding of what this will cost before it goes before the Town Meeting. This data may also help with the Assessor's Office research. Bill Costa presented maps that were created using the software. When a new well is drilled the DEP will be able to send the information to us and we can put it in our data base. GS: Who puts in the information to the data base? The Town has an IT Committee that will give you guidance as to what equipment you would need and how to protect the data. The IT Committee will also help with looking at the maintenance contract. Ted Ballard: We are paying for the maintenance every year out of the fees they charge.

On a motion made by G. Schwall Second by S. Pimental it was voted to fund the Well Mapping Project \$1,000.00 out of the Board of Selectmen IT line and to have the IT Committee take a look at the software, the security of it and to advise the Water Commission.

Discussion: Bill Costa; there is already an IT representative on the Water Commission and he will be bringing the topic in front of the IT Committee.

The Highway Department is short 16 plow trucks for the season. We have enough sanders for the season. The Department was able to repair an old sander in house, and it is now on the road. I was able to get 3 plow truck contractors to commit to the Town for this season and also two drivers. The employees will drive the newer trucks. I also have a truck sign out sheet and circle done on every truck in the morning. I will be attending a workshop to learn different ways to treating roads from people all over the country. SV.: What happened to the beet juice idea? MC.: I am learning of the costs that go into the equipment needed to dispense beet juice and I am also learning other cost effective, environment friendly ways to treat the ice. There was discussion regarding an incentive for seasonal workers at the end of the season.
