4.0) NEW BUSINESS: Action Item #1 SAFE Grant

Chief Barresi present to announce the SAFE Grant. Chief Barresi states that we were awarded with \$4,237.00 in Student Awareness of Fire Education grant and \$2,716.00 in Senior Safe Grant which was started last year to get the seniors on board because of their safety issues being a little different. The seniors may need more help. Since this grant started the children fire deaths have gone down by 70%. Unfortunately Randy Larivee couldn't be here. He spends a lot of time with the schools and the kids. We get a lot of support from the schools. We had two kids from the schools that won an award for the poster contest and I was fortunate enough to attend that ceremony in Framingham. It also gives us the opportunity to provide homes with carbon monoxide detectors who can't afford them. We have them right on our trucks and can put them in immediately. This grant is issued by the Commonwealth of Massachusetts and under written from a few different sources, including the department of fire services. Anyone who needs anything that is supplied by this grant please feel free to call us. Chairman Costello congratulated Chief Barresi on receiving the grants.

• Chairman Costello asked Chief Barresi for an update regarding the new vehicles: Chief Barresi: The new pumper truck is 80% complete and should be delivered on time in March. The chassis for the new tanker arrived at the factory last week so everything is there and that should be delivered by the second week in March. Pimental: We should give our Highway Department some guidelines on sanding. Our roads are horrible as far as ice goes. Chairman Costello said they do have a protocol and that didn't get followed. Selectmen Vadnais: I have been approached by tax paying residents. We are having problems with the accepted or unaccepted roads again and they are not being plowed in the developments. I feel as a safety issue for tax paying residents and also school buses to access these roads. I know it was being done then stopped because of political reasons a while back. I feel we have an obligation to these people. Lawson Street is one of the properties. Chairman Costello: These roads should be plowed by the developer until these roads are accepted for public safety. We should enforce it and we don't. We also don't receive Chapter 90 money until the road is accepted. We should pull from the performance bonds that the developers put up, that are on these developments, to treat these streets if the developer is not. Chairman Costello: It has to be four seasons after payement then they can request the road be accepted. Then the Planning

Board goes out with the engineer to inspect the property and roadways. I feel we should have the developer put up a bigger bond so they will get the roads accepted quicker and get their money back. Selectmen Schwall: My concern is if there is ever a medical emergency, no one is going to want to hear the street was unaccepted that's why we didn't plow. Selectmen Vadnais: My primary concern is the kids get to school in a safe manner. You brought up a number of other issues that I wasn't prepared to address at this time, but these issues need to be resolved. Chairman Costello: I feel you should utilize their bonds to deal with these roads. Selectmen Schwall: Let's get a plow through to make a path and let the developer clean it up. We can make the road drivable so that a school bus or fire truck can get down it. Chairman Costello: I will talk to Mike from the Highway Department to see if we can resolve this issue.
