OLD BUSINESS:

Action Item #1 Chapter 90 Project Request

Tabled from 12/3/18 meeting: Mike provided the Board with additional information.

Vote to approve Chapter 90 purchase of a highway vacuum excavator vehicle to clean catch basins and other areas in town. Cost to be approximately \$355,000.00

- > M. Costello It is very expensive to rent this type of machinery and I do not have the money in my budget. Federal Law-MS4 requires that we clean the catch basins 2 times a year. To rent a machine is approximately \$272K per year. In three years, this proposed machine will be paid for and will give us many years of service. Chapter 90 helps with the payment, it is state money that has been allocated for this purpose.
- > J. Muri- Actually in 6 months the machine will pay for itself.
- D. Perry- Could we lease one to see how it works, before making such a large purchase?
- M. Costello Clam Shell will not work as well and only does ONE job. This purposed machine does 3-4 different functions.
- ➤ D. Perry I looked into a leasing company in New Jersey and we can try out the machine, train our people on how to use it and get the worse part of the work done. It is \$700 per day, \$3200 a week or \$9K a month.
- > S. Vadnais What is the time frame during the year that we need this machine and how many employees would you need to work on it?
- > M. Costello We would need it April thru June and again October thru November. Two current employees would need to work with the machine. The company will train the employees on how to use the machine.
- S. Vadnais Maintenance on the machine can be a nightmare.
- M Costello The vehicle would be garaged when not in use. If we lease the vehicle, we cannot use Chapter 90 funds and I don't have a lot of money in my budget to work with.
- D. Perry I agree we need the machinery because the catch basins are a mess, but I feel we need to think this through, it is a very large purchase. We can lease one first and see how it works, then if we decide to purchase one, we will only be using it to maintain the basins and other road work.
- > George Solas I'm hearing a lot of confusion with this equipment. I agree with Dave that renting the machine is the best way to go so the town can test it, get employees trained and see if it is really something that the town needs.
- > J. Muri Mike has done a lot of research on this and Chapter 90 funds do not come from tax payers It will pay for itself very quickly.
- > Tish Vadnais Is it possible to use another town's machine? Can we sell the clam shell?
- M. Costello Other towns will not let us use their equipment for 3 months. The clam shell machine is not worth too much since it is from 1998.

- ➤ Chip Ventura The proposed machine I feel is too big for our town because once the major clean up is done, it will end up just sitting in the garage. I have worked on large machinery and it can cost approximately 70K a year in maintenance.
- ➤ M. Deignan We can back fill a line at the Special Town Meeting in May, to help you with the leasing of the equipment so you don't have to wait until FY20.
- S. Vadnais Our plan is potentially work on a back-fill line for Town Meeting, then look into leasing a machine in the Spring, with future plans of buying one.
- > S. Vadnais We can table this discussion while Mike and Dave work through this.
- J. Muri motioned to table purchase of Vacuum Excavator for discussion on leasing with the intention of purchasing one in the future. Second by D. Perry. Vote 3-0 M. Costello abstained.

DEPARTMENT HEAD REPORTS

Selectmen's Reports:

Vadnais: How are we coming along with the hiring of a PB/ConCom Agent?

➤ D. Perry – Need more updates to narrow it down, working on it.

Schwall: Absent

Perry: I am the Harbor Freight liaison and I met with Mass Dept of Fishery to work on launching a ramp on Rt. 6 (near Clam Shack) that will be used for canoes and kayaks. Our highway department can help with the project and get paid for it.

Muri: COA continues modifications to HVAC system and it is being done with grant money. Municipal Building Committee will be meeting on Wednesday at 5PM at COA. Once again, I will be working on the reorganization of ZBA.

Costello: No Report
