Town Administrator's Report:

- \$50,000 for Senior Center will be received in the form of a reimbursement. The Board thanked Steve Howitt for keeping this in the budget for the Town.
- Dam inspections were performed last Thursday, awaiting reports. Perryville Dam has a couple minor issues and should be taken care of as soon as weather permits. Village Dam is in good structural shape, needs some weed control.
- COA need carbon monoxide detectors. Home & Commercial gave us a quote to hook into security system.
- I added an additional prior year bill to Special Town Meeting Warrant for \$657.45 payable to ARC RI for posters for new municipal complex.
