#### **Town Administrator's Report:**

- Good Energy prepared required report to DPU and sent out separate reports on behalf of Towns. The Town's Municipal Aggregation Program service has been provided by ConEd. ConEd has been bought out by Constellation. Residents electric bills will reflect the new name in about 3 months and they will also receive a letter of the change. We will also post the information on our website when we have confirmation of the date of change.
- Dave Lenart Dam Inspections has tentative plans to inspect dams on 12/14/16. The last Perryville Dam inspection was December 2011. Village Pond Dam is a non-jurisdictional dam due to its small size. It is the responsibility of the dam owner. Mike Costello and Leeann Bradley have both been informed. Conscom has agreed to pay the cost of the inspections.
