- > Rehoboth Police Department has notified us that someone is going to residents' homes and identifying themselves as census representatives. We are informing the public that no one from the Town or State is going door-to-door in Rehoboth so please be aware.
- Chris Gauthier- Cross Street; CARCS; Follow up on what Town's stand would be in regards to the Compressor Station and to draft a resolution to have more of an impact. Chris presented a list of people that CARCS would like to have receive the resolution or letter. Chris gave documentation to the Board regarding a scoping hearing and forming new Town bylaws to protect the Town of any future threats. The Board assured Chris that Town Counsel and the Selectmen have been already working on changes to the Town Bylaws.

#### Action Item #2: Discussion Re: Public Safety Building Deficiencies/Non-Compliance Issues

Chief Trombetta & Paul Rene, owner of Rene Detention Systems present.

J. Trombetta: Rene Detention Systems is a company that has given us a quote to rectify the deficiencies list that was given to us by the State. The Police Department has been written up several times and will be fined soon for the deficiencies of the building.

Paul Rene explained that Rehoboth's Police Department is one of the worst buildings he has looked at. The lock up facilities are all out of compliance. Paul is afraid that the Town could suffer law suits if someone gets hurt in the lock up facility. It will take approximately \$100,000 per cell to bring to compliance and another new male cell with a sally port is needed at approximately \$200,000. The worst-case scenario is that the State can shut the cells down.

J. Trombetta: Asked to have ceiling and roof inspected for mold and mildew due to leaking and also have vents cleaned. The Board agrees and will look into having an engineer come in to inspect Town buildings fully.

On a motion made by S. Pimental Second by G. Schwall for discussion it was voted to add a contingency line on Special Town meeting for any findings from an engineer pertaining to the Town Buildings in the amount of \$300,000 for remediation.

The Board will request money from Reserve Fund pay for engineer.

On a motion made by S. Pimental Second by J. Muri it was voted to open STM Warrant. All Vote 5-0

On a motion made by S. Pimental Second by G. Schwall it was voted to add a warrant on Special Town meeting for any findings from an engineer pertaining to the Town Buildings in the amount of \$300,000 for remediation. All Vote 5-0

On a motion made by S. Pimental Second by J. Muri it was voted to close STM Warrant. All Vote 5-0

S. Meagher from Ambulance: We lost a lot electronics because of the roof leaking and we will soon need a different vehicle due to State regulations and we have no room to house it.

Ted Rowse: Discussed the plan for the Public Safety Building and at least doing that building for approximately \$5,000,000, instead of using money towards the existing building. He also discussed building a new Town Hall where the old one sits. Ted Rowse and the Board does not

know what the underground conditions would be and it may be costlier than building the Town Offices at a new location.

George Solas: The cost for the solution is so much cheaper than fixing the problem temporarily. M. Deignan: Has the tiles been tested for asbestos? Yes; T. Rowse handed Mike a copy of the asbestos report. Has the water been tested? Yes. Mike would like these reports posted and available for residents to see.

#### Action Item #3: Municipal Complex/Town Offices

M. Costello: Handed informational packets on several different modular trailers to the Board of Selectmen and discussed different options. To lease modular on a 24-month lease for a 4 unit would be \$9,000 per month plus set up and break down costs of \$13,000. To buy the modular would be \$750,000. The extra costs would be wiring, plumbing and moving equipment in.

#### Action Item #5: FY2018 Town Operating Budget

M. Deignan present: Mike went over a tentative budget.

Approximately \$465.000 in free cash, does not take into consideration of Article 6; Security System for the schools \$8,800(we will know more Monday night)

\$125,000 increase in motor vehicle tax; local receipts \$150,000 more; we have over a million-dollar deficit.

To balance the budget, we would use \$354,000 in free cash; reduce school budget request by \$310,000; the finance committee also made reductions on the requests from the Town side. The finance committee does not think the Town is able to fund four new police officers. S. Pimental voiced the need for four officers. The discussion was brought up about de-regionalizing K-8 and each town pay for their own. The Board of Selectmen and Finance Committee set up a Financial Summit Meeting for April 27, 7PM at the COA.

#### Action Item #6: Review of 5/8/17 STM & ATM Warrants

Leeann will provide comments for the two Zoning bylaw amendments from Planning Board this week. G. Schwall will assemble a letter for the warrant and send out for review.
