4.0) NEW BUSINESS: Action Item #1: Water Commission

Joe Nunes, Ted Ballard, Tish Vadnais present: We (Bob Ashton: Board of Health; Dr. Hermance; Ed Bertozzi: Finance Committee & Water Commission) would like to start a program. We would like to map out wells in parts of the town so that we collect enough data so that we can determine if we have enough water capacity and where the water is coming from for the mapped out residents. We would be working with the DEP and college students at Roger Williams College, if the Board gives us permission to do so. There is no cost to the Town.
