June 13, 2016 Skip Vadnais and Dave Perry will be meeting with Attleboro Mayor Dumas and Representative Steve Howitt. The gas compressor station will be within a 2 mile radius from two of their schools and we would like to see if he has a contact person to forward information to. The assessors have sent a letter of notice to all areas of concern. The letter Identifies Assessors Map 67/Lot 22A. S. Vadnais read letter that was sent. We received notice that the Environmental Impact Statement has begun and ends May 30, 2016. S. Vadnais read the notice letter. We are tracking that report. We also received a letter of concern from a resident at 39 Williams Street. Many concerns we have been discussing and the decibels concern is being monitored by the Planning Board. We sent a letter to Congressman Kennedy sharing our concerns. We did receive a response and should be posted on our website.
