- T. Charnecki; We are donating a conservation restriction to Rehoboth Land Trust of approximately 30 acres of undisturbed land near the Perryville Pond off 6 Danforth Street. This has been approved by the State. We have gone through the Planning Board to identify the parcel of land.
- A. Latham; This is a real plus for the Town. It also abuts other land that has a conservation restriction. A conservation restriction remains in private hands but cannot be developed on.

Pimental: Regarding social media: no one was paid off to assess the Town Buildings. We hired an engineering company to come in and evaluate both buildings. We needed someone who can tell us all the deficiencies and how to remedy them. We are responsible to find a solution to this situation if we are not going to get approval to build a new Town Building. We are obligating to our employees to do something. If anyone has any questions please come in front of the Board.

Perry: The new Forestry Truck is in and in use; The new pickup truck for Highway is in and getting a plow installed.

Muri: (in regards to S.P. comments) To get an engineer we had to follow certain Procurement Laws. We (Selection Board) selected the most qualified out of the bids that we received. The Selection Board existed of 30 qualified people of engineers and architects. The company we chose is going to do an extensive examination of the buildings structure and air quality testing. This will generate a report and tell us exactly what is wrong with the buildings and how to bring them to code. *Ron Whittemore & Donald Welshman, thank you for working on the punch list and being a big help. *IT Committee- is working on Policies to bring to the Personnel Board, as well as GIS Software *ZBA meeting September 3rd regarding Anawan School Housing. It is not Section 8 Housing open to all, it is for elderly housing. This project is being driven largely by State Law. If you are interested in learning facts please attend the upcoming meeting.

*We received correspondence from Town Counsel in regards to the marijuana article from earlier this year- the recommendation was that we pursue consideration of a general bylaw. (agenda item for the future)
