Action Item #8: Request by "Citizens Against the Compressor Station" to submit questions to Spectra

A new list of questions were given to the Board of Selectmen. D.Perry: I have read every question and met with Bill Ryan of Spectra. I submitted all the questions previous and will forward these as well. There are sixty-one questions here. We called this meeting Spectra did not. They are coming voluntarily; this is not a requirement hearing. Spectra will address all questions that have been brought up. We have not had additional dialogue with Spectra other than what you are already aware of. We have also invited Attleboro and Seekonk to attend meeting. Attleboro has schools that are within a two mile radius. The deadline to questions will be September 15, 2016 by noon so that no one is walking in meeting with a list of questions. We do need to give them time to read and answer questions. Tracey Manzella: You say that the Board is neutral but yet you post a press release for Spectra. D.P. They are coming here to address your questions. S.V. If you have meetings coming up you can have your group come in at open forum to announce the meeting date, place and time. We are hosting this event so that is why we put a press release out. Anne Jarosz: I believe they need to give time to answer all our questions. S.V. They will. Tish Vadnais: The Selectmen are here to help you as much as they can. Joe Noons: Will they be bringing plans as to what the facility will look like? D. P. They will be making a quick presentation and then answering questions. They may come with plans, plot and elevations. I will suggest that to them. S.V. We have volunteers now that meet in small confined areas.
