# Action Item# 2 Pole Location Petition from National Grid & Verizon- 415 Fairview Ave

- ➤ G. Schwall amended his motions to stated that the liquor would be transported on 8/17/2018 & 8/19/18 and 8/24/18 & 8/26/18. M. Costello seconded the motion. Vote 4-0
