- Lorraine Botts: Bizarre October 22, 2016, asked to put up signs; On a motion made by S. Pimental Second by G. Schwall it was voted to allow signs to be put up around Town advertising the Bizarre, signs being removed no more than 3 days later. All Vote 4-0
- Chief Trombetta informs the Town regarding Thursday September 15<sup>th</sup> issue at Cumberland Farms. A man threatened to set the pumps on fire, called 911 hung up, and after 5 hours of a major standoff, he was apprehended safely. Was bit by the K9 when he ran. The police department, swat team, fire department, highway department and all others involved did a great job. Officers stood up at meeting and were recognized for a job well done. #### Action Item #2: Quotes for Mold Remediation for Town Hall

Town Clerk: We have found that the mold entered the vault by bringing old assessor's records from the Anawan School. The dehumidifier has kept it stable. I received quotes from; Polygon, Belfor and BMS. All three companies were highly recommended. Polygon, being the lowest bid of \$8,587.76, has a contract with all the libraries of MA, worked with the FBI, the Pentagon, universities, corporate archives, etc. Is there reoccurring maintenance needed? L.S: Yes, since it is a cement vault the moisture will keep getting in. On the warrant you will see that I put in for a ceramic modular vault system. It can be put in our vault now and if we move or expand it can be moved. Once you get a proper type vault you no longer need a maintenance plan. It was also suggested that the HVAC system be cleaned as well. This vault holds our entire Town records.

On a motion made by D. Perry Second by S. Pimental it was voted to hire Polygon for the mold remediation in the Town Hall vault and to approve the Reserve Fund Transfer for \$10,000. All Vote 4-0
