- Members with connections will ask if we could present at the Antiquarian Society and the Holiday Craft Fair.
- R. Panofsky will revisit the FAQs drafted under the leadership of J. Nunes. He will circulate them for suggestions and then prepare a final version for our use.
- R. Panofsky offered to prepare a draft version of a flyer/brochure to use as a handout.
