Purchase of Land:

The Board of Selectmen walked the land and are on track with the owner to have a Purchase & Sale Agreement by Town Meeting. It is near public safety building.

Conceptual Plan

Ted Rowse and the Selectmen are working together to create a conceptual plan for the Town Offices and Public Safety Building. This parcel has no constraints, relieves restrictions by not having two buildings together. Survey needs to be done on land prior to purchasing: soil samplings, ground water testing.

Chief Trombetta emphasized the need to more space for officers and dispatchers. He mentioned possible using the old plan that was developed years ago.

Dave Foss-School Street. He feels the Selectmen should not renovate any of the buildings. To save money, do projects in phases; all ground engineering done in one shot, then one building at a time. Educate voters through web, schools, mailer, regarding the ongoing operating costs of the aged buildings.

John Pacheco- Hornbine Road: Mentioned using Prefab or shell construction. He handed the Selectmen information on Morton Buildings. Save on prevailing wage.

Scott Meagher- Ambulance Committee- no room for staff, especially overnight shifts.
